Automotive Fluids	Containers
<p>Used oil that has been contaminated with gasoline, diesel, carburator cleaner or any other solvent will be treated as a flammable liquid, not as used oil.</p> <p><input type="checkbox"/> EPA Requirement Advised</p> <p>Used oil mixed with paint, pesticides, antifreeze, cooking oil, or any other substance will be charged as misc. material and</p> <p>Commercially-generated used oil is not eligible for the State</p>	<p>A maximum of 3 containers will be emptied and returned at the Ukiah facility while you wait. Containers can be no larger than 5 gallons and must contain used oil or antifreeze.</p> <p>We are no longer returning flammable liquid containers. Please bring flammable liquid in a disposable container.</p> <p>We do not accept propane tanks larger than 8 gallons</p> <p>We will dispose of up to 3 drums or tanks (steel or poly). Other limits still apply to the contents of the drums.</p>

<p>Pound</p> <p>To dispose of explosives such as fireworks, marine flares, or ammunition please contact your local law enforcement or fire department.</p> <p>Asbestos or asbestos-containing material must be handled by a licensed company. More info can be found here: www.dir.ca.gov/databases/doshacru/acrusearch.html</p> <p>Ink Cartridges Each 10 0</p> <p>Compressed gas cylinders can be taken to a gas supply company.</p>	<p>Electronic waste must be taken to the transfer station or to another e-waste recycler</p> <p>Used tires must be taken to the transfer station or to another tire recycler</p> <p>Electronic ballasts without PCB's must be taken to the transfer station</p>
Pharmaceuticals and Sharps	
<p>We cannot take medication or sharps from doctors' offices, pharmacies, or hospitals. We can take medication or sharps from commercial entities who collect these materials from employees or residents (at care facilities).</p> <p>All dry medication must be delivered in resealable plastic bags without bottles. All liquid or gel medication must be in their original container with patient information removed and placed into a resealable plastic bag separate from the dry medication.</p> <p>All sharps must be delivered in approved sharps containers no larger than 1 gallon in size, clearly labeled, sealed, and not overflowing.</p>	
Propane	
<p>Effective 10/3/19 we are no longer accepting any propane tanks larger than 20 pounds.</p>	
<p>EPA ID IS REQUIRED: *Federal regulations require large and small quantity generators of hazardous waste to obtain an EPA Identification (EPA ID) number using EPA Form 8700-12 and to submit the completed form to the authorized state agency or EPA regional office if the state is not authorized to implement the Resource Conservation and Recovery Act Subtitle C program. If you do not currently have an EPA ID, you can apply for one online for free at:https://dtsc.ca.gov/apply-for-hazardous-waste-epa-id-number/</p>
